The board of directors and all directors of China Shenhua Energy Company Limited guarantee that the information set out in this announcement does not contain any false statements, misleading representations or material omissions, and severally and jointly accept responsibility as to the truthfulness, accuracy and completeness of the content herein.

Recently, Generator No. 1 of the Newly Constructed Project of Jiangxi Shenhua Jiujiang Power Plant (the “Project”) of China Shenhua Energy Company Limited (the “Company”) has successfully completed the 168-hour trial operation and been transferred to commercial operation.

During the trial operation of Generator No. 1 of the Project, the parameters and energy consumption indicators reached the designed standards, while the emissions of soot, sulfur dioxide and nitrogen oxide reached the “ultra-low emission” standards. Two 1000 MW ultra-supercritical coal-fired generating units were built and Generator No. 2 has been put into commercial operation in June 2018.

The Project is located in the High-tech Industrial Park of Hukou County, Jiujiang City, Jiangxi Province, and was constructed and is being operated by Shenhua Guohua Jiujiang Power Co., Ltd., a wholly-owned subsidiary of the Company. After commencing production, the required coal is supplied by Shenhua Shendong Mines and transported by railway, sea and river.
