On 1 December 2011, the National Development and Reform Commission released six notices on the adjustment to power tariffs (the "Notices"), including the Notice on the Adjustment to the Power Tariff of China Southern Power Grid (Fa Gai Jia Ge [2011] No. 2618). Pursuant to the Notices, the on-grid power tariffs for coal-fired power plants in the respective regions shall be adjusted. Certain upward adjustments have been made to the on-grid power tariffs for coal-fired generating units in the regions where China Shenhua Energy Company Limited (the "Company") operates its principal power business, including:

In addition, the generating units which have installed and operated denitrification facilities, upon the examination and approval by the relevant competent authorities of environmental protection and price supervision, could enjoy a denitrification price, which is RMB8.0/MWh under a temporary power tariff standard.

Pursuant to the *Notices*, the weighted average on-grid power tariffs (including value-added tax) of the equity power output dispatch for the first 10 months 2011 of the Company's power plants will increase by approximately RMB25.6/MWh after the adjustment. The above adjustments have been implemented since 1 December 2011.

The on-grid power tariff herein refers to the power tariff corresponding to power usage as specified in the sale and purchase agreement of power supply entered into between the power company and the power grid company.
