The board of directors of China Shenhua Energy Company Limited (the "Company") and all the directors guarantee that the information contained in this announcement does not contain any false representations, misleading statements or material omissions, and accept joint and several responsibilities as to the truthfulness, accuracy and completeness of the content of this announcement.

On 27 November 2009, No.4 Power Generation Super-critical Unit of Hebei Guohua Cangdong Power Company Limited (the "**Huanghua Power**") with capacity of 660MW successfully passed 168 hours trial operation and was put into commercial operation simultaneously, representing the successful completion of Huanghua Power phase II capacity expansion project.

As at the date of this announcement, Huanghua Power with the installed capacity of 2,520 MW, which includes two sub-critical power generation units with capacity of 600 MW individually and two super-critical power generation units with capacity of 660 MW individually. Huanghua Power is a power plant with the largest installed capacity in Southern Hebei Power Grid. No.4 Power Generation Super-critical Unit of Huanghua Power made use of in-house 10000-tonne level low temperature multi-effect sea water desalination equipment for water cooling. The average utilization hours of power generation unit of Huanghua Power amounted to 5,509 hours.
