In the first half of 2016, the Company's coal sales volume increased by 4.8% year-on-year, which was primarily due to (1) a rebound in coal demand in major downstream industries for the first half of the year; (2) the Company's developing new market and strengthening sales of coal purchased from third parties by fully utilizing its own transportation capacity. The total sales of power output dispatch was recorded a year-on-year increase of 1.1%, mainly attributable to an increase in installed capacity of the Company's power generators.

The major operational data above were calculated based on the internal statistics of the Company. As a result, operational data may show major differences between months. The factors giving rise to such differences include, without limitation to, bad weather, equipment overhaul, seasonal factors, safety checkup and so on. The major operational data may somewhat differ from the data disclosed in the relative periodic reports.
