The board of directors and all directors of China Shenhua Energy Company Limited guarantee that the information set out in this announcement does not contain any false statements, misleading representations or material omissions, and severally and jointly accept responsibility as to the truthfulness, accuracy and completeness of the content herein.

Recently, Generator No. 1 of the Newly Constructed Project of Shenwan Lujiang Power Plant (the "**Project**") of China Shenhua Energy Company Limited (the "**Company**") has successfully completed the 168-hour trial operation.

During the trial operation of Generator No. 1 of the Project, all technical and economic indicators reached the designed standards, while the emission concentration of soot, sulfur dioxide and nitrogen oxide reached the "ultra-low emission" standards. It is proposed to build 2×660 MW ultra-supercritical coal-fired generating units, and the construction of Generator No. 2 is advancing at a steady pace.

The Project is located in Lujiang County, Hefei City, Anhui Province, and was constructed and is being operated by Shenwan Hefei Lujiang Power Generation Co., Ltd., a wholly-owned subsidiary of Shenwan Energy Company Limited, which is a controlled subsidiary of the Company. The Project selects ultra-supercritical coal-fired generating units, to which a combination of a number of advanced technologies are applied, such as syncretism of stack and cooling tower with high-level water collection, flue gas waste heat utilization by the deep couplings of team turbine and boiler, and external steam cooler of nine stage extraction heat. Meanwhile, the lower temperature electrostatic precipitator + wet flue gas desulfurization (WFGD)+ synergistic removal technology on wet electric deduster + low nitrogen burner + selective catalytic reduction (SCR) technology is also under progress, with the purpose of establishing a digital power plant which is safe, reliable, economical, efficient and environmentally friendly.
