The board of directors and all its directors of the Company guarantee that the information set out in this announcement does not contain any false statements, misleading representations or material omissions, and take legal responsibility as to the truthfulness, accuracy and completeness of the content herein.

Recently, No. 3 power generation unit of the Phase II Expansion Project (the "Jiujiang Phase II") of China Energy Shenhua Jiujiang Power Co., Ltd., a wholly-owned subsidiary of China Shenhua Energy Company Limited (the "Company") successfully passed the 168-hour continuous full-load trial operation and has been transferred to commercial operation.

Located in Liusi Town, Hukou County, Jiujiang City, Jiangxi Province, the Jiujiang Phase II is designed to build two 1,000 MW ultra-supercritical double-reheat coal-fired power generating units. The project applies advanced technologies and equipment, including steam-electricity dual-drive induced draft fan technology and the 220kV three-phase integrated main transformer. The designed coal consumption rate for power generation is 259.92 g/kWh under pure condensing conditions and 249.8 g/kWh under combined heat and power conditions, ranking among the most advanced levels in China.
