A total of 21,100,500 H Shares repurchased were cancelled by the Company on 8 March 2021. The Company's 2020 annual general meeting held on 25 June 2021 considered and approved the relevant reduction of its registered capital by RMB21,100,500 to RMB19,868,519,955. At present, the Company is processing the procedures of change in industrial and commercial registration for the above reduction of registered capital.
